Legal Agreement -- Product Sales Terms and Conditions

The following terms and conditions apply to your purchase of products from ADVANCED CHEMICAL SOLUTIONS LLC. By placing your order, you agree to be bound by these terms and conditions, which constitute the entire agreement between you and ADVANCED CHEMICAL SOLUTIONS LLC regarding the products purchased.

Ordering: Your order is subject to acceptance by ADVANCED CHEMICAL SOLUTIONS LLC and may be refused for any reason, including credit concerns, restricted product, unusual volumes, or shipping addresses. Once accepted, ADVANCED CHEMICAL SOLUTIONS LLC may make partial shipments if some items are on backorder. By placing the order, you agree that ADVANCED CHEMICAL SOLUTIONS LLC may do so and charge you for any items shipped.

Pricing: The price for each product purchased is reflected on your order and will remain the price regardless of any subsequent price changes by ADVANCED CHEMICAL SOLUTIONS LLC. In addition to the quoted product price, you may pay hazardous material fees, export/import fees (international orders) shipping and handling charges, plus all applicable taxes.

Taxes: ADVANCED CHEMICAL SOLUTIONS LLC shall automatically charge and withhold the applicable sales tax for orders to be delivered to addresses within Utah for non-exempt customers. Each customer shall be solely responsible for all sales taxes, or other taxes, on orders shipped to any other state.

Cancellation: Orders may not be canceled that have already been processed.

Payment: Payment in full is due prior to shipment unless customer has been approved for ADVANCED CHEMICAL SOLUTIONS LLC credit terms or COD payment. Standard credit terms are 50% payment due at the time order is placed with the balance due NET 15 after order has been received. ADVANCED CHEMICAL SOLUTIONS LLC will accept payment via bank wire transfer or company check. **ADVANCED CHEMICAL SOLUTIONS LLC will require payment in full prior to shipment for all international orders.**

Shipping: ADVANCED CHEMICAL SOLUTIONS LLC will ship products according to federal regulations using best methods available. ADVANCED CHEMICAL SOLUTIONS LLC will attempt to ship the products within the estimated times reflected on your order but will not be liable for any failure to do so. If ADVANCED CHEMICAL SOLUTIONS LLC learns it cannot ship within the estimated times, you will be advised via email or phone call of the new estimated shipment date. For items on backorder, ADVANCED CHEMICAL SOLUTIONS LLC may ship whenever the product becomes available without any notice to you. Shipping charges are non-refundable.

Title: Title to all products passes to you upon delivery of the product to the selected carrier.

Returns & Warranty: All products are sold without warranty of any kind and purchasers will, by their own tests, determine suitability of such products for their own use. **NO CLAIMS FOR LOSS, DAMAGE OR LEAKAGE ALLOWED AFTER DELIVERY IS MADE IN GOOD CONDITION TO CARRIER, WAREHOUSE OR RAILROAD DEPOT.**

Restocking Fee: A 30% restocking fee will be applied to all returns for refund. Shipping charges are non-refundable. No refunds for special ordered items. No refunds after 15 days.
